

# USA-2000 Labeling Standards - Down & Feather Products (Jan. 2009) **Bedding and Apparel**

#### The American Down & Feather Council (ADFC) supports the standards developed by ABFLO and first enacted as regulation by the State of California. Documents referenced include:

<b>Down Products</b> Any product with at least 75% down cluster may be labeled " <b>DOWN.</b> " The minimum down cluster % <b>MUST</b> be listed.	Cleanliness Requirement Oxygen of 10 or less and Turbidity of 300mm or greater.
<b>Down/Feather Blends</b> The minimum down cluster content of blended products must be labeled. No tolerance is allowed.	Requirement for Hypoallergenic or Super-Clean Claims Oxygen of 4.8 or less and Turbidity of 500mm or greater.
<b>Feather Products</b> The label <b>"WATERFOWL FEATHERS"</b> may be used if the product has at least 80% waterfowl feathers.	Fill Power Claims After proper conditioning, the fill power of finished products should be $\pm 5\%$ of claim. Steam Conditioning is the official IDFB method.
Labeling of Other Components If other components exceed the maximums in the chart below, the component % must be labeled.	Species (GOOSE or DUCK) Products can be labeled by species if 90% of the plumage is of that
