UNIFORM REGISTRY NUMBER (URN) or "REG. NO." REGISTRATION NUMBER

USA

This number identifies the location of the MANUFACTURER that made the finished product. This number is required by **15 USA States** to sell products in their state.

STERILIZATION PERMIT NUMBER or "PER. NO."

This number identifies the factory location where the down/feather was sterilized. Each sterilization factory must have their own permit number. This number is required by **6 USA States** to sell products in their state.

Other Numbers:

REGISTERED IDENTIFICATION NUMBER (RN)

This number is issued by the Federal Trade Commission (FTC), upon request, to the business residing in the U.S. and engaged in the manufacture, importing, distribution, or sale of textile, wool or fur products. Businesses aren't required to have an RN, but can use the RN in place of a company name on the label that is required to be affixed to those products.

CA IDENTIFICATION NUMBER

A CA Identification Number, commonly referred to as a "CA Number", is issued by the Competition Bureau upon request. Only Canadian manufacturers, processors or finishers of a textile fibre product or Canadians engaged in the business of importing or selling any textile fibre product are allowed to register for a CA Identification Number. Such dealers are not required to have a CA Identification Number but they may use it in place of their name and address on the label of consumer textile articles.
